- Defective machinery delivered
- Inspection and sorting costs

The sublimit amounts to € 15.000.000 per occurrence with a double annual aggregate.

8. Automobile Recall Costs

The limit amounts to € 2.500.000 per insured event with a single annual aggregate.

9. Recall Costs (not Automobile)

The limit amounts to € 2.500.000 per insured event with a single annual aggregate.

10. Environmental Impairment Liability

€ 15.000.000 combined for bodily injury, property damage and covered pure financial loss

per occurrence with a single annual aggregate


11. Insurance of Environmental damage

The limit amounts to € 10.000.000 for insured costs with a single annual aggregate.
